Cycle Thefts – Five cycles stolen between 16/08/2013 & 17/08/2013, where two cycles were stolen from cycle racks on Havelock Gardens (**Theft** x 2), one cycle stolen from a cycle shed on Checkland Rd and two cycles stolen from a shed in the rear garden of a property on Ashfield Rd (**Burglary other than dwelling** x 2). Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports.

Drugs [Cannabis Factory] – On 22/08/2013 about 22:30hrs, call received by a member of the public reporting damage / insecure door of a property on Melton Rd. On Police attendance, search conducted of property and cannabis cultivation equipment found along with a large quantity of cannabis plants. Report still under investigation.

Damage to motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. First report was damage to tyres, Second report was damage to windscreen, Third and Fifth reports were scratches to panels of vehicle, and Fourth report was dents to panels of vehicle.

Theft of motor vehicle – For both reports on Pinfold Rd, vehicles were hired to customers who have not returned vehicles. Both reports still under investigation.

Theft from motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. The First and Third reports were entry gained into insecure vehicles and items stolen. Second report on Humberstone Ln, where catalytic converters stolen from 6 vehicles whilst parked on business premises car park. Fourth report on Melton Rd, where window smashed to gain entry into vehicle whilst parked on business premises car park, and items stolen. Fifth report on 'Retail Park' car park where number plates stolen from a vehicle. And Sixth report on Market Garden Cl where an attempt to gain entry to vehicle by damaging locks.

Burglary other than dwelling – The Fourth report on Westmoreland Ave where forced entry gained into business premises and items stolen.
