**Burglary other than dwelling** – First report on Church Hill Rd where forced entry gained to business premises and items stolen. Second report on Pinfold Rd where forced entry gained to business units but no items stolen. Unfortunately No Witnesses/Suspects/Forensics/CCTV.

**Burglary dwelling** – First report on Dovedale Rd was rear window smashed to gain entry and items stolen. Second report on Thorndale Rd was rear window forced open to gain entry and items stolen. Third report was an attempt on Humberstone Ln where rear window glass cracked but no entry gained. Fifth report on Festival Ave was rear door forced to gain entry and items stolen. Fourth report was a distraction on Southdown Dr where two suspects have posed as bogus council officials and gained entry into property and distracted the occupant and some items stolen before being disturbed, and suspects ran off.
