[Incidents of note :-

On 01/07/2014, officers conducted search at a property on Spencer Ave and found 2 persons in possession of drugs.

On 20/07/2014 about 15:00hrs, report received of an air weapon discharged in a property on Wayside Dr, where people gathered for wedding party. Numerous officers attended the location, and a male arrested. Report currently under investigation.

On 22/07/2014 about 19:00hrs, report of a male with stab wounds and covered in blood, walking around Colby Rd / Humberstone Ln area.. Officers attended and located male, on questioning / enquiries, identify male had self harmed after an argument.

Anti Social Behaviour –

On 06/07/2014 about 22:00hrs, group of male youths on Manor Medical Centre car park, drinking alcohol and shouting / swearing, causing disturbance.

On 10/07/2014 about 19:00hrs, group of younger youths / children shouting and kicking footballs at properties / parked vehicles, causing disturbance.

On 12/07/2014 about 20:00hrs, group of male youths on Manor Medical Centre car park, drinking alcohol and shouting / swearing, causing disturbance.

On 16/07/2014 about 17:00hrs, 2 male youths on Checkland Rd car park shouting, causing disturbance, and possibly causing damage to bin sheds.

On 16/07/2014 about 23:30hrs, group of 6 drunk youths (males & females) on Brackenfield Way, shouting / swearing causing disturbance.

On 17/07/2014 about 22:30hrs, group of about 5 drunk youths (males & females) on Windmill Cl, shouting / swearing causing disturbance.

On 17/07/2014 about 23:30hrs, 2 male youths on mopeds riding around Windmill Cl estate revving engines and constantly beeping horns, causing disturbance.

On 18/07/2014 about 20:00hrs, group of male youths on Silverdale Dr, kicking footballs at properties.

On 23/07/2014 about 23:00hrs, 2 male youths, possibly drunk, on Windmill Cl bumping into vehicles.

On 25/07/2014 about 22:00hrs, group of youths on Offranville Cl, drinking alcohol & smoking drugs, shouting / swearing, causing disturbance.

On 17/07/2014 about 00:30hrs, group of drunk youths (males & females) on Windmill Cl, shouting / swearing causing disturbance.

On 26/07/2014 about 23:30hrs, group of youths on Offranville Cl, drinking alcohol & shouting / swearing, causing disturbance.

Damage to motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. For all reports, the vehicle panels were scratched and/or dented.

Theft of motor vehicle – All reports currently under investigation. First report on Melton Rd, where vehicle hired has not been returned, and reported as stolen. Second report on Rookery lane was an attempt theft of motorbike, where suspect was disturbed by owner. Third report on Pinfold Rd, where vehicle stolen from car park of business premises.

Theft from motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. First, Second, Third, and Fifth reports were items stolen from insecure vehicles, parked on driveway of properties. Fourth report was theft of catalytic

converter from a van parked on car park of business premises. Sixth report was theft of works tools from van parked on driveway of property.

Burglary other than dwelling – The **Third report on Melton Rd and Fourth report on Bridge Park Rd**, a male suspect arrested and charged with both burglaries at business premises. On 21/07/2014 about 3pm, staff challenged a male who was in restricted area of business premises, and could not provide identification, and alerted Police Officer who was near location. Officer found property belonging to other businesses on Melton Rd & Bridge Park Rd from the male, and arrested male at the location.

Unfortunately No Witnesses/Suspects/Forensics/CCTV for other reports. **First and Eight reports on Dukes CI** were forced entry into unoccupied business premises. **Second report on Ferndale Rd** was door forced to gain entry into rear garden garage and items stolen. **Fifth, Sixth, & Seventh reports** where door locks damaged to gain entry into rear garden sheds and items stolen.

Burglary dwelling – The **first report on Margaret CI**, between 14/07/2014 about 12:00hrs & 15/07/2014 about 11:00hrs, side kitchen door window smashed to gain entry into property and items stolen.

Second report on Humberstone Ln, On 27/07/2014 between 20:00hrs & 23:45hrs, rear kitchen window forced open to gain entry into property and items stolen. Currently under investigation.]
