On 14/03/2014 a warrant was executed at a property on Checkland Rd, where cannabis plants were found and seized. Male occupant receives Caution.

On 29/03/2014 about 22:00hrs, a member of the public receives facial injuries by a male, who was with a group of males, when calling the police in relation to damage caused to a vehicle parked on Melton Rd, by a male from the group. **Anti Social Behaviour** – On 10/03/2014 about 16:00hrs, report of about 5 youths congregated near flats on Checkland Rd and possibly smoking cannabis.

**Damage to motor vehicle** – Unfortunately No Witnesses/Suspects/Forensics/CCTV for the first six reports. The first report on 'Retail Park' where vehicle panels were scratched. Second report on Church Hill Rd where windscreen was smashed. Third report on Earls Way where door window smashed. Fourth report on Melton Rd where vehicle panels were dented. The fifth report on Clayton Dr and sixth report on Blount Rd, both reports were damage to wing mirrors. The Seventh report on Melton Rd where windscreen smashed is currently under investigation.
