**Public Order** – On 12/11/2013 about 19:00hrs, report of drunk male making threats with a knife to other residents on Victoria St. Male arrested and charged with possession of offensive weapon.

**Drugs** – On 17/11/2013 about 00:30hrs, a vehicle stopped on A607 Newark Rd and cannabis found on person. Charged with possession of Class B drugs.

**Damage to motor vehicle** – The First report, paint thrown over vehicle, on Melton Rd between 21:00hrs & 22:00hrs on 20/11/2013. Unfortunately No Witnesses/Suspects/Forensics/CCTV. The Second report on 'Retail Park' where victim sat in vehicle parked in car park, and male from another vehicle causes damage to window of vehicle. Report currently under investigation as victim identified male's vehicle and noted registration number. Enquiries ongoing.

**Theft of motor vehicle** – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all four reports. First report was van stolen from lay-by on countryside road. Second report of motor scooter stolen from Checkland Rd and found same day on Red Hill Ln. Third report of motor scooter stolen from Unicorn St and found same day in the canal off Canal St. Fourth report of motor bike stolen from Canal St and found next day in the canal off Canal St. Second, Third, and Fourth reports were a motorbike & motor scooters stolen between 23/11/2013 about 18:00hrs & 24/11/2013 about 08:00hrs.

**Theft from motor vehicle** – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. First report on Church Hill Rd where number plates stolen from a vehicle parked on business premises car park. The Second report on Dukes Cl where damage caused to 3 vehicles parked on business premises car park to gain entry and items stolen. Third report on Colby Dr where items stolen from insecure vehicle.

**Burglary other than dwelling** – The First and Second reports on Humberstone Ln were the same business premises targeted, where forced entry gained into premises and tools stolen. Unfortunately No Witnesses/Suspects/Forensics/CCTV. The Third report on Thorndale Rd was items stolen from a garage, where door locks damaged.
