Cycle Thefts – Nine cycles reported stolen, where three cycles were stolen from Pinfold Road Marina (**Theft** x 3), two cycles stolen from a shed in the rear garden of a property on Beacon Ave (**Burglary other than dwelling** x 1), and two cycles stolen from a shed in the rear garden of a property on Melton Rd (**Burglary other than dwelling** x 1). Unfortunately No Witnesses/Suspects/Forensics/CCTV for these reports.

One cycle stolen on 13/09/2013 from outside a shop on Humberstone Ln – Suspect identified from CCTV and arrested & charged (**Theft** x 1). Attempt theft of one cycle on 27/09/2013 from cycle racks on business premises on Melton Rd – witness calls Police and two males arrested & charged (**Theft** x 1).

Theft from Person – On 01/09/2013 about 15:45hrs, report of gold necklace snatched from an adult female whilst walking on Manor Rd, by male suspect (**Theft** x 1). Unfortunately unable to identify suspect and no further Witnesses or CCTV.

Building Site Burglaries / Thefts – Two reports on Deacon Dr (**Burglary other than dwelling** x 2). And one report on Silverdale Dr (**Theft** x 1). Various building material stolen. Unfortunately No Witnesses/Suspects/Forensics/CCTV for these reports.

Drugs – On 11/09/2013, Police Officers conducting search of a property on Sandiacre Dr, and some cannabis found. Occupant charged with possession of Class B drugs (**Drugs** x 1).

Public Order – On 08/09/2013 about 15:30hrs, male youth is verbally abusive and threatens two members of the public walking on Sandiacre Dr. Suspect identified and report currently under investigation (**Public Order** x 1). On 21/09/2013 about 23:40hrs, two groups of youths verbally abusive to each other and minor altercation on Spencer Ave. Police Officers attend location and after an immediate area search, four youths arrested (**Public Order** x 1). Two of the youths arrested were in possession of cannabis (**Drugs** x 2). Reports currently under investigation. On 29/09/2013 about 00:45hrs, Police received reports of a disturbance on Melton Rd. Officers attended and arrested male suspect for possession of offensive weapon. Report currently under investigation (**Public Order** x 1).

Assault (ABH) – On 07/09/2013 about 00:15hrs, group of male youths assault a person known to them, whilst walking on Checkland Rd. Four male youths named and arrested. Report currently under investigation.

Damage to motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. First report was scratches to panels of vehicle. Second report was damage to door locks. Third report was dents to panels of vehicle. And fourth report was windscreen smashed and scratches to panels.

Theft of motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for the single report on Dovedale Rd.

Theft from motor vehicle – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. The First report was entry gained by forcing open door of vehicle and items stolen. Second report where window smashed to gain entry into vehicle and works tools stolen. Third report was number plates stolen from a vehicle.

Burglary other than dwelling – Unfortunately No Witnesses/Suspects/Forensics/CCTV for all reports. The Four reports on Pinfold Rd Marina where forced entry gained into 4 boats and items stolen. The Second and Sixth reports were cycles stolen from sheds [**Cycle Thefts**]. Third report on Church Hill Rd where forced entry gained into business premises and items stolen. Fourth and Fifth reports on Deacon Dr where building items stolen [**Building Site Burglaries / Thefts**].

Burglary dwelling – Unfortunately No Witnesses/Suspects/Forensics/CCTV for the first report on Charnwood Ave, where entry gained to property via insecure rear door, whilst occupants upstairs, and items stolen. Second report on Blount Rd, about 19:30hrs two male suspects were disturbed by occupant, whilst at home, as suspects were trying to force open rear window of property. Unfortunately unable to identify suspects and no further Witnesses or CCTV.]
